There is little to report at this date as we have had little correspondence from our men, but we feel sure that the next issues will be full of rumors as we are requesting each of you to do your bit and send us in news.


The past reunion was well represented by 330th men but we will double that next year if each of you plan now to attend in Cleveland, August 20, 21, 22, 1953.


Following the organizational meeting members and wives had luncheon together.
