



MEMBERS OF THE 908TH F.A. WILL TURN OUT IN FAR GREATER NUMBERS THAN EVER BEFORE AT THIS YEARS GRAND 34TH. ANNUAL REUNION TO BE HELD AT THE MAGNIFICENT MARRIOTT IN PHILADELPHIA.

SUBMITTED BY M. BRICK A-BTRY 809TH F.A. Recently, I checked over my files on the articles that I had written for the THUNDERBOLT. I began writing so that I could express my thoughts and my respects for the many men that served in G 331 in World War II. I had written about the replacements, the runners, clerk, mail clerk, communication personnel, supply personnel and jeep drivers.

With the Convention in New Orleans dominating my time I have been unable to continue the articles on those individuals that I owe a great deal of gratitude and thanks for making my position as Company Commander an easy task and a very rewarding

one.

When I entered the 83rd Division in October 1943 at Camp Breckenridge, I had been in the army a little over a year, spending my time between various service schools and the training of replacements. As an ROTC cadet, I had many hours of training in Discipline, Command and Leadership. During the year before joining the 83rd, I had a chance to put into practice the many things that I had learned from the text books. The principles behind the training are outstanding, but the practical work and the application of those principles cannot be proven until you become part of the Army. In that first year I was able to apply myself to those principles. It was a learning experience. I thought that I had learned everything that I needed to know. That was a mistake I made, because when Bill Waters assigned me to the Weapons Platoon of G 331, I found that I knew very little about the Light Machine Gun and the 60 Mortars. I had a lot to learn and very little time to learn it. With Division test being conducted I felt that the only way the weapons platoon would pass those test was for me to call upon someone who knew his job and knew how to run the platoon. I was very fortunate that I had Sgt. Clyde Flannary to turn to. Flanary was what we called an 'ole soldier' and had more years in service, than I had time in the chow line. Flanary told me that all I had to do was follow him around during the test, and do what ever he was doing. It worked, the platoon passed the test and I got an education. Flanary had trained the platoon and had selected a group of NCO's to run the sections and the squads. Carl Wheeler, Beau Titus, Bo James, Herb Barton did outstanding jobs training the personnel. I worked with this group for six months, and by the time we sailed for Europe, we had become a close knit platoon and felt that the training in the states welded us into one of the finest platoons in the Division.

Once we entered into combat, all of that training, that we had spent in the states and in the hills of Wales, paid its dividents. We realized that there would be casualties, so that when the casualties began to come in, all of the NCO's were ready to step in and assume the leadership roles. Unfortunately, we lost a number of key sergeants early in combat. Flanary performed an outstanding job as platoon sergeant until he was wounded in the St. Malo area. Carl Wheeler and Bo James had the mortars doing an excellent job, until an entire group was lost in an unfortunate incident. With these sergeants out of action, it was Beau Titus's turn to step forward. Without hesitating Beau stepped into the job and performed in an excellent manner. He remained as weapons platoon sergeant for the remainder of the combat in Europe.

Until we entered into the St. Malo area, I had served practically all of my time with the weapons platoon. I had served from time to time with one of the rifle platoons and also as executive officer. I had known most of the sergeants from the training days at Breckenridge and in the early combat in Normandy, but I had not been as close to them as I was with the members of the weapons platoon. When wer reorganized after St. Malo, Capt. Waters the CO went to the Battalion Staff and as a 2nd St. I was given command of G Co. This was indeed a reward for me. I had assumed a Job that carried a great deal of responsibility and I would need all the help that I could muster in order to do the job that was expected of me. We had only myself and one other officer in the company, before the replacement officers arrived. That is when I looked around to see what sergeants I had in the rifle platoons.

I knew that in Mort Gaynor, that I had a solid top sergeant. Mort had been through Officer Candidate School, but through a technicality he did not receive a commission, he had successfully completed the course. This was a God sent to G Company, Mort was available when I needed assitance in handling the administration end of the command. He performed his job as a First Sergeant, I had no worries in that part of my command.

In the states I had gotten to know some of the personnel in the three rifle platoon. The platoon sergeants were experienced in their jobs. Singleton, Yeary, Bertinetti did commendable jobs. Once in combat, we lost two the three within a few days, and the third only a few months after. Advancements had to be made, we were fortunate in G Company to have squad leader who could step into the job of Platoon Sergeants. There were men like Frank Bunk, Bob McAbee and Loyal Pangle. Once these three men took over the platoons, it was evident that I was a vortunate Company Commander, to have these men available to assume command of the platoons. With Pangle, we had an individual who had also gone through OCS and due to a technicality he did not receive his commission. He did an outstanding job as platoon sergeant, and was a NCO who was able to do it all. At times I knew he was not satisfied with the ways things were going, but he would always stay in there and pitch. It was a relief to know that I had men like Gaynor, Titus and Pangle, that I could depend on.

Once in Combat, when officer casualties were out weighing the replacement officer, it was necessary to reward these outstanding sergeants with Battlefield commissions. I offered commissions to Gaynor, Titus, Pangle, McAbee and Bunk, for some reason they all refused. It is amusing that even to this day when we meet each year at the reunion, neither one of them can give me a reason as to why they refused the commissions.

These are the noncommissioned officers in the unit that held the positions at the platoon level. When we got down to the squads, we were extremely fortunate to have a continuous group of men to assume command of those units. These are the men that bore the brunt of the casualties. It seemed as though I was always looking at new squad leaders. It is hard for me to recall the names of all the men that had a chance to command the squads in G Company, but I felt that I was always secured at that level. Some of these men did a tremendous job, all of them did a commendable job. Men like Myer, Kosobuncki, Krull, Schwartz, Rung, Paradis, Budd, Kontoulas, Piette (his job was keeping Berlet and Titus on the ball) Naelrod, James Balke, White. I know that I left out quite a few names, but believe me without these individuals my job as CO would have been a difficult task. Because of these men and me like them that made up the 27 rifle companies in the 83rd, The Division went on to achieve some of the greatest victories in modern warfare. My hat is off to those unsung heroes of the American Army, The Sergeants.

Mr. Derickson,

I'm sending this article to you in hopes you will publish in one of the issues of the Thunderbolt magazine. All of this happened last August but this is the first opportunity I have had to write to you about it. I hope you can publish this and also put a piece in the magazine concerning my husband in hopes someone remembers some of the events that happened. He is trying to get a service pension and needs someone to verify the facts.

He was a member of the 83rd Division, Co. L, 330th. He has been in bad health for the past three and a half years. He had back surgury in June of '76, was home two weeks when he developed an embolism and was back in the hospital for another two weeks. The doctors couldn't get his blood stabilized. Then is September of '77, the doctor took him off of coumidan and five weeks later he had another embolism. In the meantime, he had had five hemorrages, two mild heart attacks and is still trying to work. We aren't sure, but we think a piece of shapranal worked into the disc of his back and caused the herniaded disc. He was wounded by schapranal at St. Lo, France on July 25, 1944.

When he started working at Proctor & Gamble in 1947, everything went fine until a piece of schapranal worked out of the side of his right foot and another piece worked out of his big toe; therefore we are fairly certain a piece worked into the disc of his back because it happened so fast. Within three days, he had to have surgery.

If you cannot use this article in the Thunderbolt, could you please return it. It is the only copy we have and I would like to keep it. We would appreciate knowing if anyone remembers Delmar McLaughlin and what happened. Mr. Watkins wasn't in any shape to remember what happened. Maybe the medic on the line (if still living) will remember.

'I Thought He Was Dead'—But.



June Watkins and Delmar McLaughlin talk about their war experiences.

A German shell whistled into the hedgerows of St. Lo. France, on July 25, 1944, and left two American infantrymen wounded.

June Watkins of Winston-Salem lost his left arm and was riddled with shrapnel. Bits of the same shell hit Delmar McLaughlin of Batavia, Ohio, but injured him less seriously.

McLaughlin summoned medics for Watkins and helped them remove him from the battlefield.

As the stretcher disappeared down the road, McLaughlin said he thought to himself, "He's a goner. That is the last I will ever see of him."

In fact, McLaughlin was so certain that Watkins had been fatally wounded, "I just assumed he was dead."

But a month ago, McLaughlin discovered that Watkins did not die. And this week they have been holding a reunion after 35 years.

How do both of them feel about the reunion?

"Man, it's great!" both said.

Watkins, now 60, and a resident of 3345 Old Salisbury Road, and McLaughlin, now 58, met for the first time in October 1942, when both were assigned to Camp Atterbury, Ind.

"We were among the first soldiers assigned to the 83rd Infantry Division when it was formed," said Watkins. "And we became great buddies and spent a lot of time together."

Both were finally assigned to the same squad in Co. L. 330th Regiment of the 83rd Division. Watkins as a scout and McLaughlin as a Browning automatic rifleman.

They landed in France shortly after the invasion of June 1944 and were fighting in the hedgerows of Normandy when they were wounded.

"I had been wounded a couple of times earlier," Watkins said, "but I got it real good at St. Lo."

McLaughlin recalled that he had "absolutely no hope for June when I saw him lying there — the way he looked to me he couldn't make it."

The day after Watkins was wounded, the 83rd, which had been pinned down in the hedgerows, put its soldiers on the sides of tanks and moved 90 miles at one time.

"It was a real breakthrough," McLaughlin said.

McLaughlin continued with the 83rd until near the end of the war in Europe in May 1944. He was aboard a ship en route to the United States for leave when the armistice came.

Watkins meanwhile had been treated at a field hospital in France, then went to England for several weeks and finally to McCloskey General Hospital in Temple, Texas.

Watkins left the service on April 16, 1945, and returned to Winston-Salem. He was declared 100 percent disabled.

McLaughlin left service in October 1945. He had entered the service from South Carolina but lived there only a year after his discharge and went to Ohio to work for Procter and Gamble.

Watkins said he had thought about McLaughlin frequently through the years and had tried to locate him in South Carolina "because I thought he went back there."

McLaughlin said he had thought about Watkins — "but since I believed he was dead, I did not try to locate him."

About a month ago, Watkins noticed McLaughlin's name in the magazine of the 83rd Infantry Division, "The Thunderbolt," and wrote him to ask if he was the same McLaughlin he had known.

When the answer came back, "yes," the two immediately planned a reunion.

McLaughlin and his wife, Anita, came down from Batavia, to spend a week with Watkins and his wife, Ermalee.

The four were happy over the unexpected reunion.

"And I am glad that June isn't dead," said McLaughlin. "I am afraid I have thought that for 35 years."

The indoor tropical atmosphere around the pool created a delightful setting for some good drinking.

We also have taken some photos at the party which I am sending you some, of which you pick the one's that you want to put in the magazine.



11 October 1944

The 329th Infantry and 330th Infantry continued patrolling. Enemy activity was light.

The 331st Infantry, in Division Reserve, continued training.

Task For POLK continued patrolling aggressively from SIERCK LES BAINS to the South in the Division zone. Troop B sent three patrols out to the river under cover of darkness. No enemy activity was seen.

At 2400 83d Division was relieved from XX Corps, Third Army and assigned to Ninth Army. The same order transferred following organizations with 83d Division: 453 d Anti-Aircraft Battalion, 802d Tank Destroyer Battalion (to wed) and the 774th Tank Battalion. Task Force POLK and GROUPE TACTIQUE LORRAINE were relieved from attachment to Division, and placed under control of XX Corps.

The boundry between the Third and Ninth Armies moved North to STENAY, LONGOYON AUMETZ, SIERCK LES BAINS',TRIER.

What Has Happened to Camp Atterbury?

Is Atterbury "the land of opportunity"? Opportunity for whom might be a better question. In 1940, when it seemed that the United States would become actively involved in World War II, residents of Johnson and Bartholomew Counties were aroused by the acquisition of almost 41,000 acres by the Federal Government. Many lives were disrupted as landowners and tenants alike were hurriedly moved out and hundreds of skilled and semi-skilled workmen swarmed over the farmland.

Approximately six months after the land acquisition began, a typical Army infantry camp was born just 40 miles south of Indianapolis.

What is the status of this temporary camp stand today, 40 years later? The land is still here. Many of the scars from World War II, the Korean War and the Vietnam Conflict have healed or have been rearranged. The 5th Army slowly moved out a little at a time. Since the property is in public ownership under control of the Federal Government, the use and or disposal of this land comes under a prescribed plan passed by Congress.

In 1963 a parcel of land along the Driftwood River just below the confluence of Big Blue River and Sugar Creek was declared excess to military needs. The land was first offered to several different Federal agencies, none of which was interested. The land was then offered to State agencies through a parent federal agency. That is, the Indiana Department of Natural Resources was approached by the United States Fish and Wildlife Service. The Department refused the offer because of funds to purchase and develop it. Title was finally acquired by the United States Forest Service, which is a unit of the Department of Agriculture. So today that tract is a part of the gradually developing Hoosier National Forest.

In 1969 another parcel of 5,409

acres was declared surplus. After due and complicated process it was purchased by the Indiana Department of Natural Resources and assigned to its Division of Fish and Wildlife. Federal funds derived from an excise tax on the sale of firearms and ammunition were used to pay for 75% of the cost. State license fees provided the other 25%. This was the start of the Atterbury State Fish and Wildlife Area. [See Outdoor Indiana: November 1971; June 1972; September 1978.]

Development of the property has proceeded nicely, with the sportsmen's money continuing to pay most of the bills. To date, nine lakes and marshes have been constructed and two or three more are planned. Five boat launching ramps, six pit toilets and a primitive campground allow enjoyment of this area with as little disturbance to the natural setting as possible.

This is all available to the public at no charge other than a minimum overnight camping fee. Of an annual 200,000 man-days usage of Atterbury only about 35-40,000 is for hunting or fishing.

The removal of almost 700 buildings and planting of more than 300,000 trees and shrubs in a 10-year period has begun to alter the landscape. Open fields and assembly grounds have disappeared, with a natural succession of plants beginning to show. Flora and fauna unseen for many years are starting to return.

The largest part of the original camp — approximately 34,000 acres —has been leased to the State of Indiana for use by the Indiana National Guard.

This land is used for military purposes by the Indiana Guard, the Indiana Air Guard, and guard units from surrounding States. The United States Army Reserve Center is another tenant of the old camp.

Parts of the present military area are open to the public in ever-increasing usage when it does not conflict with the military objectives. For instance, there are the cooperative Deer and small game hunts, mushroom and berry picking, and the viewing of Deer and other wildlife. The cooperation between the Indiana National Guard and the Indiana Department of Natural Resources is splendid. While public use of part of this military area continues, visitors should remember they are guests of the Army and should conduct themselves accordingly.

Another tenant of former Camp Atterbury is the United States Department of Labor. It, in turn, has sublet to two tenants. One is an apprenticeship school for heavy equipment operators operated by their union. The second tenant is the Job Corps, which occupies the old hospital area and part of the former warehouse complex. The Job Corps is a vocational school for underprivileged young adults.

Another tenant of about 800 acres occupies a broken horseshoe-shaped area surrounding the Job Corps complex. This area was donated to Johnson County by the United States Government to be used as a local park and recreational area. Some features of this area will be similar to those of the State Fish and Wildlife Area. However, most will not parallel, for the basic concepts between a Park and a Fish and Wildlife area are quite different.

The last tenant fills a function as a utility company. The water and sewage systems of the old camp were acquired by Prince's Lake, and are maintained to supply all Atterbury tenants as well as several neighboring communities.

That is the disposition of the Camp Atterbury land and facilities to date. It is your choice as to how you can best use and enjoy these facilities. The continued wise use of them can provide recreational opportunities for many generations to come.
