I mistakenly stated that "I" Company was on both sides of the Pommelte – Barby Road in the advance to Barby where "L" Company was North of this road and "I" Company was on the South side of this road. I knew that four tanks were assigned to "I" Company but I only saw two of them to our right in this big field. I then assumed that they were across the road to our left. Looking at the map I obtained, it is difficult to make out the "L". I am very sorry about this blunder and apologize.

Well, another Reunion of the 83rd Infantry Division has come and gone and was again, a very

pleasant affair. I would like to extend my congratulations to Wm. M. Minick for the fabulous job he did by carrying on as the National Secretary/Treasurer, Executive Board Members and the rest of the Officers of the 83rd Inf. Division Assn. And also to Armed Forces Reunion Inc., Salavatore Scicolone, President and Reunion Chairmen, Al Silverio, and anyone I may have overlooked. Last but not least, to Tony Vaccaro for his time, expense and patience in showing the membership his great documentary and his explanation of things to come, for a job well done – congratulations to all.

I would also like to remind the membership that their stories are of great importance for the proposed movie that will eventually be made and perhaps there will be a young actor playing the parts of, say for instance, You, or Sgt. Ed Pogoda, Pappy Hewitt, Harvey Estes and Sgt. Wilmer Phillips and how about you guys in the Field Artillery? Without your artillery fire, we would not have been able to advance. How about you men in the Military Police? Also vital to the success. How about Kent O'Connell, was he at that suicide corner directing traffic in the Bulge? How about you Medics that took care of the wounded, under fire? I saw two of you in the woods in the advance to the St. Vith-Hoffalize Highway. How about you guys in the Signal Corps.? How about your engineers, without your bridges, where next? Headquarters too? All of these individual stories need to be documented and put together for an accurate movie. Tony Vaccaro has indicated that he will pursue his phase of this project as he has had a filming crew for some time now but he needs material such as the stories from you. Be proud of being a Veteran of the greatest Infantry Division in the world, compare the records. I have ordered five more Combat Reports that the 83rd was involved in and will keep you updated on what I receive.

I have detected the following: Either President Roosevelt or Truman ordered the Western Allies to halt on the West Bank of the Elbe River or perhaps General Eisenhower gave the order on his own, never the less, the 83rd Inf. Division and the 2nd Armored Division reached the Elbe. XIX Corps Headquarters then issued Field Order #32 and #33. The 2nd Armored and the 83rd Infantry were ordered to cross the Elbe River, establish a bridgehead and be prepared to attack East and/or Northeast - Berlin? The Military and the Government was reluctant to admit the fact that we invaded Eastern Europe. This is why the 83rd was ordered to turn the bridgehead over to the I have located four books that are Russians. entitled "The Last Battle" and using this title for the movie should not be a problem as I see it.

Bob McNabb, son of James McNabb of Wayne, PA, "K" 331st has been active in pursuing his Congressman, Curt Weldon in regards to the credit the 83rd Inf. Division deserves. He is also pursuing the presentation of the Proposed Unit Citation that has eluded the 83rd through all of these years and also my pet project, the 6th Battle Campaign by leaving the Central Europe Campaign area, crossing the Elbe River into First things first, the Unit Eastern Europe. Citation presently has priority. I want to thank Bob for his efforts and this shows that Descendant members also play a vital role for the 83rd. I have also learned that there are now ten divisions that have Honorary, Descendant and Associate members, the 83rd make it 11.

And remember, we were the best of the best and on the top of the list – check the records. Pain is temporary – Pride is forever. My best wishes and regards to all and keep well.

According to this Filed Order, the XIX Corps assumed the following: the enemy is incapable of organizing a defense line west of the ELBE River in one week. The enemy is not capable of mounting a substantial counterattack in the Corps sector west of the river either and further there has been prepared no defenses of the line on the east bank of the ELBE. Enemy troops on the front of the Corps are similar to the type that faced Task

Force Twaddle on the south. That is, they were made up of various groups.

The objectives of the XIX Corps were that the "western force" (Task Force TWADDLE) was to attack south and west to clear the RUHR pocket in its zone in conjunction and coordination with the XVI Corps plus elements of the First US Army. The "eastern force" was to continue to attack east in its zone and seize in their sector crossings of the ELBE and be prepared to attack east or northeast.

Primary troops: Task Force TWADDLE; 8th Armored Division, 194 Glider Infantry Regiment, 809 TD Battalion (SP); 95th Infantry, 709 Tank Battalion, 802 TD Battalion (SP), 15th Cavalry Group, 5 field artillery battalions and I chemical motor battalion, eastern force: 30th Infantry Division, 743 Tank Battalion, 823 TD Battalion (SP), 125 Cavalry Reconnaissance Squadron; 2 Armored Div., 702 TD Battalion, 119 Infantry Regiment; 83d Infantry Division, 736 Tank Battalion, 643d TD Battalion (SP), 113th Cavalry Reconnaissance Squadron, 6 field artillery battalions.

In the attack proposed by this field order, 390th Infantry Division was to protect the north flank of the Corps. They were to maintain contact with XIII Corps on the left (north) and 2d Armored Division on the right. 2d Armored Division was to seize and secure crossing of the ELBE River after attacking east and clearing the enemy in its zone. The 83d Division was to protect the Corps' right flank and maintain contact with VII Corps on the right or south and the 2d Armored Division on the left or north. The 83d Division was also to seize and secure crossings over the ELBE. I RCT (removed from the 83d Division) was to act as Corps reserve and be assembled in the vicinity of HALLE (C2578). The RCT was to be prepared to advance to the east or to control the civilian population.

The task assigned to the Task Force TWADDLE was to clear the enemy from the zone west of the line GESEKE (B5338) – NUTTLAR (4708) and north of the RUHR River. They were to maintain contact with the III Corps. They were then to continue west to make contact with the XVI

Corps. Once that was accomplished they were to work in conjunction with the XVI Corps to reduce the RUHR pocket.

At this date enemy units in contact on Corps front from north to south were: 3 battalions (300 each), Combat Team BURG, Regiment LANGEMEIR, SCHARNHORST, Division, 2 battalions (400 and Regiment MAHLOW: each) SCHARNHORST Division with 2 battalions (400 each). There was no enemy artillery on the Corps front of any consequences but there was expected to be met a variety of self-propelled armored guns. It was estimated that there were 50 armored guns and tanks available along the entire front at this time. In the Harz Mountains it was estimated that in the Corps zone there were 1,500 troop remnants of POTSDAM Division. The Corps' mission, as set-up by this field order, was to defend the line of the ELBE River in its sector, maintain and defend the existing bridgehead and occupy and govern the assigned areas. The troop list of the Corps on 19 April had as its primary units 2d Armored Division, 88th Armored Division, 83d Infantry Division (113th Cavalry Group attached), 30th Infantry Division, and in the Corps artillery 5 field artillery groups and 13 field artillery battalions. The missions assigned the individual units were: 30th Infantry Division: To relieve elements of 2d Armored Division, defend the line of the ELBE River in its sector and perform military government duties in its area. 83d Division: Was to defend its line along the ELBE River and maintain its bridgehead. It was also to occupy and govern its area. The 8th Armored Division was to continue to carry out its assignment in the HARZ Mountains while the 2d Armored Division was to maintain the sector in BRAUNSHCHWEIG-IMMENDORFthe WOLFSENBUTTEL area.


Shopping, touring, is high on the agenda but just being together is the best part of all. Business is handled in order. I am happy to say, "Our future looks bright".

The nickname "Bazooka Ed" stuck.

Eddie was wounded during Company actions July 29, 1944 in France and again December 12, 1944 in Germany. Known awards of Ed's, the Purple Heart with Oak Leaf Cluster, Combat Infantryman Badge, EAME Theater Ribbon with three bronze stars, Good Conduct Ribbon, World War II Victory Medal. Ed was a faithful member of the 83rd Infantry Division Association, a very active member of the Michigan Chapter and a very loyal supporter of "F" Company activities. We all will miss Ed greatly. To Jean and Tom from the Co. "F" Family to yours please accept our sincere thoughts and prayers during the time of your bereavement.


Mr. August Farias,

RE: Recognition and Thanks to Luther Strunk, Co. I 300th 83rd Infantry

Dear Mr. Scicolone and Mr. Minick.

May I introduce myself? My name is Dave Dimmick, son of Charles Dimmick, Company I 330th 83rd Infantry. He passed away on January 30, 2000. Dad never talked much about the war but I did manage to retrieve bits and pieces of information.

Dad served as a Platoon Sgt. in 1st platoon of CO. I 330th. In the early afternoon of January 6th, 1945 his platoon was moving up with a group of tanks on what he thought was the town of St. Vith, Suddenly he found himself on the ground with a severe wound to his left knee. A wound that he said he could shove his fist into. Loosing blood at a rapid rate, he grabbed his canteen and wedged it between his legs to slow the loss of blood. If he tired to move he thought he would probably bleed to death so he decided to stay put and take his chances. He did not know how long he laid there but he did not think it was but just a few minutes, when a fellow soldier showed up scrambling around him pulling fallen timbers, logs, tree tops, etc. up around him. At first he thought, "What in the hell is this nut doin." In the process, this fellow soldier was wounded in the arm by what Dad thought was a sniper located

in the direction of a nearby church. The young fellow soldier scampered back to the relative safety of a small house from which he had just left to aid my father and received first aid to his arm. Both were eventually evacuated to a hospital in Paris.

The fellow soldier I am speaking of is a gentleman by the name of Luther Strunk. Our family and Luther have stayed in Christmas card contact ever since that day of January 6th, 1945. In fact, Luther has just returned from a trip to Belgium and remarkably located the area where he and my father were wounded. He is planning to attend the reunion.

If you think it appropriate, please feel free to post our families recognition and thanks in the next Thunderbolt. Luther is not one who seeks recognition and I think may be somewhat embarrassed by it. It is not our intent to ever embarrass him only express our thanks and gratitude.

May the 83rd have a rewarding reunion of thoughts, prayers, and memories.

Ralph Bishop Gunderson

Ralph B. Gunderson was born September 26, 1916 in Indianapolis, Indiana. The only child of George M. & Lillian Bishop Gunderson, died in Pompano Beach, Florida on October 5, 2001. Veteran, he served in Co. "D" 331st Battalion Headquarters with the 83rd Army Infantry Division from July 1942 to October 1945 in World War II. He was wounded in the battle of the Bulge. Ralph loved the 83rd Infantry Division with all his heart and it was said that Company D 331 won the war! He attended 33 consecutive reunions - only missing the 2001 Reunion, which was held on his birthday. He died nine days later. He also wrote the Company D 331 Newsletter for the THUNDERBOLT.

He was a graduate of University of Cincinnati School of Business where he was a member of the Sigma Phi Epsilon Fraternity and also attended Chase Law School. He was employed by the State of Ohio in the Claims Division before entering the Army. After WWII, he was employed by the Internal Revenue Service, Cincinnati, retiring after 32 years. He was elected for two terms to the City Council of Taylor Mill, Kentucky, serving as its Vice Mayor. He was also appointed to the Regional Planning Commission for the Northern Kentucky Tri-county area. was commissioned a Kentucky Colonel by Gov. Wendell Ford.

After retiring to Pompano Beach, FL in 1976 he owned the Gunderson Accounting Service until 1990.

He was instrumental in forming the Florida Chapter of the National 83rd Division Association serving as Chapter president, Chaplin, and treasurer. He had the distinct honor of being elected to the National 83rd Division Executive Board twice resigning as chairman of the Board in April of this year due to ill health. He was also past President of the National Association of Retired Federal Employees Chapter 558 in Pompano Beach.

He is survived by his wife of 36 years, Geraldine (Geri) Dance Gunderson, a daughter, Carole Massey (Romeo) of Tallahassee, FL, son, Richard Emminger of Pompano, granddaughters Kelly Emminger & Kristina Emminger, both of Washington, D.C., and grandson Christopher Massey of Pompano. Preceded in death was son, Lawrence (Larry) in 1967.

He suffered greatly the last few weeks as he had cancer and emphysema. He will be missed. A memorial service was held at John Know Village in Pompano Beach on October 13. Interment will be in Spring Grove Cemetery, Cincinnati, Ohio on November 10.

Navajo "Code Talkers"
honored for secret duties

WASHINGTON – Allen Dale June shrugs off suggestions that he's a hero. He doesn't think about the past, he says. But, finally, he and the 28 other World War II "Code Talkers" have medals that prove they are.

Just five of the Navajo Indians are alive, and only four were well enough to come to the Capitol on Thursday to accept Congressional Gold Medals from President Bush. Proud family members represented the others.

The medal is the highest civilian honor the nation can bestow. The CoDe Talkers were honored for creating a code from their native tongue that, indecipherable by the Japanese, was credited with saving thousands of lives and turning the tide of decisive battles in the Pacific theater.

"Today, we honor 29 Native Americans who, in a desperate hour, gave their country a service only they could give," Bush said in the packed Capitol rotunda. Today, we give these exceptional Marines the recognition they earned so long ago."

June, of West Valley City, Utah, said he was just 17 and lied about his age so he could enlist in the Marines in 1942.

"Naturally we were concerned about the survival (of the country) in the Great War at the time. At the same time, WE were

defending our own country, the Navajo Nation," said June.

The Navajo language is complex, and through circumlocution the Code Talkers made it even more so. For example, a colonel was encoded into the Navajo word for "silver eagle" or ataah-besh-le-gai." A submarine became "besh-lo," which in Navajo means "iron fish," and a bomber was "jay-sho," or buzzard in Navajo.

Before they entered the war at Guadalcanal, the Japanese had cracked many of the American codes. Those that hadn't been broken were to complex to be useful.

But in a 48-hour stretch during the battle of lwo Jima, the Code Talkers sent more that 800 messages with their spoken code and were credited with being a decisive factor in the Allied victory.

After the 29 Navajo had created the code, the Code Talkers group was expanded by about 300 Marines. The rest are expected to receive Congressional Silver Medals next fall.

"These unsung heroes returned to their homes on buses – no parades, no fanfare, no special recognition for what they had truly accomplished," said Sen. Jeff Bingaman, D-N.M., who sponsored the legislation to honor them. "While the war was over, their duty = their oath of secrecy= continued."

The Code Talkers had been sworn to secrecy about their roles in the war.

Chester Nez, 80, another of the young Navajos who left the reservation to serve, said when he returned his parents and family wondered why he didn't have medals or commendations.

It wasn't until 1968 that the government declassified the Code Talker project. When it did, Nez sat down with his children and explained what he did in the war, answering

questions they'd often wondered about, said his son, Mike Nez.
