
Starbuck. Dallas Williams is getting a lot of work as Chaplain.



I am writing to tell of a vacation I just got back from being in Belgium with my family. I did basically the same tour in 1991 with my father-in-law, Fiore "Frank" DeCarolis (now deceased), who was with E Co./331st Reg. We specifically found several villages that he recalled fighting through in the first two weeks in January 1945 when he first entered the Bulge as a replacement troop. These villages, as documented in the unit history book "The Thunderbolt Across Europe" were (in order) Ottre, Bihain, Petit Langlir, Langlir and Courtil. According to the book and other sources heavy fighting took place through these villages and surrounding forests for several weeks.

On this trip, we again visited these villages and specifically explored a large section of forest about 1.5 kilometers outside of Courtil that my father-in-law pointed out to me in 1991. He recalled various combat encounters with the Germans over the course of several days, which included ambushing a German patrol at night while on a listening post along a firebreak, being re-attacked when additional enemy returned in force, and being shelled by a German tank the following morning at point blank range. The only thing that saved him and the other members of the patrol was the existing foxholes they found and hid in during The culmination to these the attack. encounters was when a huge column of German troops and vehicles stopped for a break while they were still hiding in the foxholes. The GI's went undiscovered but called in an artillery barrage on the column just after it turned off the road about 1/4 mile away.

The foxholes are still there although much shallower from years of erosion and pine needle mulch filling them up. With the aid of a metal detector, we actually found unmistakable jagged pieces of shrapnel ranging from the size of a finger to the size of your palm. Some of the larger pieces even had identifiable threads on them where the shell fuse screwed in. The highlight of our finds was an M1 Garand clip containing 7 out of its 8 rounds. The clip was rusted and the rounds corroded but still all intact. It was under 6 inches of dirt on the perimeter of one

of the foxholes. As the saying goes - "if it could only talk". I consider it a direct link to E Co./331st because it was exactly where he said he was with the unit. The interesting thing was when we explored the adjacent section of woods separated by a firebreak, it was completely devoid of shrapnel and had few foxholes, thus validating his recollection of events as to exactly where the action took place. I believe his memory was so sharp as to these locations and events because it was his first introduction to combat and the experiences were indelibly burned into his memory. He had less recollection of events as the war went on for the next five months and things blurred together.

We also visited 5, yes 5, museums dedicated to the Battle of the Bulge fighting in Belgium and two American cemeteries. You come away with a sense that the Belgium people are truly grateful to the Americans for their sacrifices and the liberation of their country. The experience also gave our two children an appreciation for what their grandfather experienced when he was only 19 years old, only two years older than they are now.



Marlborough – Louis R. Sandini lived his entire life in Marlborough. He enjoyed simple things – a grilled ham and cheese sandwich from Charlie Milo's Luncheonette and dancing with friends at the Lyonhurst

Ballroom. After serving in the 83rd Infantry Division in World War II, Louis returned to Marlborough, married and eventually divorced.

Patsy Worrick-Sandini grew up in Ohio and later moved to Worcester. She, too, enjoyed dancing. Patsy married and became the mother of seven boys. Just four years later, her husband of 13 years died.

Louis met Patsy in 1980 at a dance.

"We enjoyed all kinds of dancing," Patsy said, "but ballroom dancing was our favorite."

Patsy was 48 years old, and, in her words, "Louie was a very youthful 65."

They began dating and within a year were inseparable even though he lived in Marlborough and she lived in Worcester. For 22 years, the couple saw each other every day, with the exception of two nights a week.

"Monday and Wednesday nights were his," Patsy said, explaining that Monday night he played bridge and Wednesday night he went to the Italian-American Club. "But, we always talked. It was as if we were never apart."

Louis was very active in the 83rd Infantry Division's Boston and National Chapters, having served as president of the Boston Chapter and chair of the Board of Directors of the National Chapter. According to Patsy, he enjoyed good health and walked three miles a day. Suddenly, his walks became shorter –

first down to two miles, and then one. Last February, Patsy noticed some changes in his routine. Louis's pace had become slower and hills weren't as easy for him as they once were. He began shuffling his feet as he walked and taking short naps more often.

In March, Louis went to his doctor for his annual physical. Patsy urged him to ask the doctor if he may be getting Parkinson's disease. A blood test confirmed her suspicion, and the doctor began treatment. Just as the condition was beginning to ease, Louis received a call from his doctor ordering him to come to the hospital.

"The doctor said he was bleeding internally and had lost half of his blood in his body," Patsy said.

They gave him three transfusions. Further tests revealed that Louis had stomach cancer. On May 2, surgeons removed his stomach. He recovered well enough for Patsy to bring him home, but their time together was shortlived. Learning that the cancer had spread to his liver, the doctor gave him less than three months.

"I brought Louie home and wondered how I was going to tell him he was going to die," Patsy said.

The cancer progressed so rapidly that those three months turned out to be three weeks. Louis contacted Marlborough Veterans Agent Gary L. Brown, who also served as a notary public and justice of the peace.

"He asked me to come over and witness his will and make sure all of the arrangements were in order for him to be buried at Bourne National Cemetery," Brown said.

During the course of their conversation, Brown asked Patsy where she was going to be buried. She said she had not made arrangements for herself. Brown said if they were married, Patsy and Louis could be buried next to each other at Bourne. As a divorcee, Louis feared that the church would no longer recognize him as a Catholic. Brown consulted with Fr. Larry Martineau of St. Mary's Catholic Church. The priest explained that even though the couple could not be married in the Catholic Church, they could be married in a civil service. "Lou would still be a Catholic and could be buried as a Catholic," Brown said.

The priest went to Louis at his house, took his confession, gave him Holy Communion and absolution and placed a crucifix around his neck.

"People I talked to said Lou was completely different after that," Brown said.

During the next few days, Brown made arrangements for the marriage that was to take place Friday, Aug. 9. Two days before the wedding, Louis took a turn for the worse and was taken to the Hospice Residence in Worcester. The ceremony was moved to Thursday, and Patsy and Louis were married.

On Aug. 10, Louis passed away with Patsy at his side. As promised, Brown had his ashes buried September 20 at Bourne National Cemetery with full military honors. Patsy, Louis's brother John and about 50 members of the 83rd Infantry Division attended the service. "Louie and I had a special connection," she said. "I always thanked him for loving me. Not too many men would have put up with a woman with seven kids. How lucky we were to have found each other."

Patsy still can't look at his picture without tears, but she finds comfort in the words of a poem he wrote for her. "Tis not sad to grow old if man and woman are brave and bold ... So come with me and stay, Sweetheart. I pray to God we'll never part."

These are some of my memories of Major Dodge and other accomplishments I learned of later, mostly from his son-in-law, Curt Herrick.



In the letter from the Vincennes Chamber of Commerce, they sent a check to Major Roy T. Dodge to give to the men who worked on the levee. He could not give it to us because of government regulations, so he purchased "bracelets" for all the men in A and C company. The sterling silver bracelets were engraved on the front with "VINCENNES FLOOD 1943" and our name on the back. I still have mine and would like to know how many more can find theirs.

I met Roy Dodge and his wife at our reunion at the Pines in New York. That was when he was a Brigadier General and I asked him "How do I address you?" He said "I am Roy Dodge, that's it." He was a very fine gentleman.

Major General F. W. Milburn, Commanding General, 83rd Inf. Division, Camp Atterbury, Indiana.

Dear General Milburn:

Major R. T. Dodge, 308th Engineer Battalion, whom the U. S. Engineers placed in charge of all the field operations of all Army troops in the flood protection work at Vincennes, Indiana, on May 20, 1943, performed unusual service and did outstanding work for which we are deeply grateful to him and the officers and men of his command at Vincennes.

Major Dodge, Commanding Company A and Company C of 308th Engineer Battalion arrived at Vincennes at 3:00 A.M. May 20th, and the men, after two hours rest, commenced the work of constructing more than one mile of 24" to 30" high mud boxes on the top of the existing concrete flood wall, which work was completed before midnight. With the assistance of the other troops assigned to Major Dodge, they filled the mudboxes and constructed more than one mile of 2' to 9' sandbag and soil levee, all of which work was completed by midnight.

The crest of the Wabash River flood reached this point two hours later when the water reached six to eight inches high on the mudboxes above the concrete flood wall, and was then checked by a break of the levee on the Illinois side of the Wabash River. If the aforementioned protection had not been effected in time the Wabash River would have flowed over the flood wall, possibly turning it over, through the City of Vincennes and into the Brevoort Levee District.

Major General F. W. Milburn May 31, 1943 Page 2.

Thereafter, Major Dodge and the men of his command did necessary protection work on the Brevoort Levee south of Vincennes when the levee was overtopped two nights later on the second rise of the river which followed the breaking of the levee as aforementioned.

The 350 troops under Major Dodge all worked the first sixteen hours and then one-half of the troops received six hours rest, and the balance worked, and then alternated six hour shifts until the emergency was passed. Food was served to them at their posts by the Battalion Mess Outfits.

Major Dodge and his staff thoroughly and carefully planned and prepared the work and thereafter, executed it with precision and promptness and in such a manner as to receive the respect and admiration of the other troops and civilians. The Engineer in charge of operations for the Army Civilian Engineers and the Chief of Police, who was in charge of operations for the city, and others stated that in their fifteen years of construction experience, they had never seen any work to equal it.

This letter is not only to thank you for the service rendered by Major Dodge and his troops, but to express our admiration for the ability of Major Dodge to organize, perform and complete critically required work under great pressure with calmness and assurance.

Brigadier General Roy Tinsley Dodge U.S. Army Retired

Roy Tinsley Dodge, retired U. S. Army Brigadier General and Former Chief of Design and Construction of the Washington D.C. Metro, died at Inova Mt. Vernon Hospital on November 8, 2002, of complications from lung cancer, at age 85. He was a resident of The Fairfax Retirement Community at Ft. Belvoir, Virginia.

A native of Gadsen, Alabama, he was born on 30 July 1917, grew up in a devoted family, enjoyed an adventurous youth in a rural setting and graduated from Gadsen High School. An outstanding student, he waited tables to help with Auburn University expenses while progressing to ROTC cadet engineer regiment commander. In 1938 he received a BS in Mechanical Engineering with honors and a regular Army commission.

Lt. Dodge's first assignment on the Texas and Mexican Border was with the 8th Engineer "Squadron" of 1st Cavalry Division. During that period of rapid technological change his engineer truck platoon provided water and fodder for horse cavalry on the march. As a distinguished marksman he led the Engineer team to success in the annual Camp Perry

National Rifle and Pistol Matches in 1939. Roy regaled friends with tales of that service. He met the love of his life, Gwynne Irvin Barrett, on a blind date in El Paso in 1940. They were married there on 2 July 1941.

In World War II he served with the 83rd Infantry Division. The Thunderbolt, often referred to by correspondents as the "Rag-Tag Circus". He landed in Normandy on 19 June 1944 commanding the 308th Combat Engineer Battalion and fought through 5 campaigns as part of General Patton's 3rd Army. As division engineer at the age of 27 he established the successful assault bridgehead across the Elbe River that opened the path to Berlin and linked up with the Russians.


Postwar assignments included faculty and staff at the Army Engineer School, Assistant J-3 for the Joint US Mission in Turkey, Assistant District Engineer for the Southern United States, Corps Group Engineer with the 8th US Army in Korea, and Director of Army Schools in the Continental Army Command. During his last assignment as the North Central Division Engineer he was responsible for military construction and civil works in 13 states embracing the Great Lakes and Upper Mississippi River. Additionally he was chairman of 4 US and Canadian Great Lekes international water boards. He was in charge of the project to turn off the American side of Niagara Falls to make repairs and remove rockslide debris.

Upon his Army retirement in 1967 he became Chief Engineer for Design and Construction of the Metro in Washington D.C. He supervised the offices of Engineering, Architecture, Program Control, Contract Administration, Equipment Design, Construction and Real Estate Acquisition, and was contracting officer for all design and construction activities. In applying proven Army Engineer management approaches with General Jack Graham, Roy Dodge's efforts were key in establishing and maintaining momentum within the Metro team. During his eleven years with the Metro, he applied his

firm integrity, construction engineering experience, management style, comfortable presentations and his ability to work with the Metro Board to move from the first line on a set of plans to placing the Metro in operation. The Engineering News Record selected the Metro for 1976 as one of the notable accomplishments by the construction industry in last 125 years. The 103 mile system opened in January of 2001 implemented his well-conceived master plan and achieved the status of a world-renowned Metro system.

In his second retirement he continued to serve the community and enjoy life with his friends. In several resident capacities he materially assisted the planning, construction, operations and expansion of The Fairfax at Ft. Belvoir, a commercially operated prototype for retirement communities. As a trustee he actively supported Saint James' Episcopal Church in Mount Vernon, VA. He played golf several times a week, exchanging stories and shooting his age. He enjoyed bird and deer hunting, fishing and crabbing with friends. During retirement he became a skilled wood carver.

General Dodge is survived by his beloved wife Gwynne Barret Dodge of Fort Belvoir; three children: Caroline Dodge Herrick of Annandale, Virginia, Roy Richard Dodge of Fort Worth, Texas, and Elizabeth Dodge Menikos, also from Fort Worth; eight grandchildren; and eleven great grandchildren.

Notes from a Roy Dodge letter after VE Day as copied by Mrs. Dodge in her WWII scrapbook. Please recall that with censorship Roy was unable to write specific details in his letters until after the end of the war.

"...About casualties---by the grace of God, good luck and a good outfit --- we didn't make mistakes and they never had to wait on the engineers --- which is more than I can say for any maneuver I was ever on. The

casualties in my Bn. were lighter than any other engineer outfit in a like operation. Only one office killed though several were wounded (I got so low on officers in Normandy that they had to transfer 5 Infantry officers to me!), 30 (soldiers) were killed and 120 were wounded for the entire campaign. The worst single action was on New Year's Eve --- We were laying a minefield in the bulge and due to the great demand were unable to get VS mines so we had to use some (we) were not too familiar with --- 5 of them exploded for a reason we will never know and 9 men were killed outright and 7 wounded. My "lineup most of the time has been Robbins, Ex.O, Hannaman, S3, Fletcher, S1, Boiko, S2, Vinyard, S4, Peace, H/S, "A" Co., Gillis, "B" Co., Swider "C" Co., Snaders ADE, Earle was reconnaissance office for the first half and Pisarcik the second.

Dear Cliff,

In response to our 26 December telephone call I am sending a number of items concerning Roy Dodge and the 308th Engineer Combat Battalion.

Roy as the son of a Gadsden Alabama steel worker was bright and hard working with firm integrity. He made great contributions to his country, community, church and family. He was a wise person with a fine sense of humor who was fun to be with.

Having the honor and the pleasure of the pleasure of going to France in the 1990s with Roy and playing golf with him from time to time, I wish to propose some areas for consideration in your article. As retired veteran I suspect there are at least 100 stories that go with each of the events below. I must leave the real detail to you and the other engineers who were there.

 He was very proud of the 308th Engineer Combat Battalion and men.

- 2. He recalled his reporting to the 83rd Division chief of staff upon arrival and being advised that he was very young.
- 3. He was proud of the battalion's successful performance in the Vincennes flood disaster prevention mission.
- 4. He was beholden to the hospitality of the British at Shavington Hall in Shopshire County.
- The battalion began crossing the English Channel on 18 June and landed on the 23rd and 24th of June at OMAHA beach.
- 6. On 28 June the battalion took over the positions of the 326th Airborne Engineer Battalion of the 101st Airborne Division in Normandy.
- 7. The 308th Engineer Combat Battalion fought as infantry on 6 July 1944 filling in for a mauled infantry battalion.
- 8. The battalion displayed grit in establishing the treadway bridges under fire on the nights of 20, 26 and 27 July to support the advance.
- The placing of the class 40, 140-foot Double Double Bailey, bridge across the two destroyed spans of the Dinan Viaduct Bridge at night on 5 August was challenging accomplishment.
- The battalion prepared to perform an assault demolition role in forcing the surrender of the St. Malo Citadel Fortress on 17 August.
- 11. Over 20,000 German prisoners were moved over the battalions Loire River crossing from 12 September into the POW cages constructed by the battalion. Souvenir weapons became available.
- 12. When on line and in reserve the battalion conducted training to perfect tactics for future operations and working with the infantry.
- 13. The battalion accepted the challenge of getting rid of the German submarine force food and wine stores discovered in a cave near Orleans.


- 14. The battalion continued to provide mine clearing, bridging, road maintenance, mapping, establishing obstacles and mine fields and other basic combat engineer tasks to support the advance.
- 15. The battalion participated holding the north flank of the Battle of the Bulge and moved south toward Bastone.
- Infantry Division attack with three assault river crossings over the Weser, Salle and Elbe rivers in 6 days to establish the successful Elbe bridgehead that opened the way to Berlin.
- 17. The battalion supported the link up with the Russian 6th Guards Division at the Barby crossing on the Elbe.

SUBJECT: Commendation.

TO : Commanding Officer, 308th Engineer Battalion, APO 83, U. S. Army.

- 1. The crossings of the Rhine, the Weser, the Leine and the Elbe Rivers within the short space of sixteen days mark a high point in the history of the 83d Infantry Division on the Continent. The major contribution by the 308th Engineer Battalion toward this achievement provides me with the opportunity of expressing my appreciation for your performance.
- 2. The impetus of the drive from the Rhine to the Elbe River was sustained in large measure by the skill and rapidity with which your troops supported crossings of the Weser River on 7 April and the Elbe River on 13 April. But perhaps more worthy of praise than the assault crossings of these rivers, is the manner in which your troops maintained the Elbe River bridges. In spite of repeated bombing and strafing attacks, enemy artillery fire, drifting mines and swimming saboteurs, men and officers of the battalion made certain that the bridges remained intact.
- 3. With respect to our holding the bridgehead, I am aware that this was made possible in large measure by the fact that between the time of the initial crossings and the completion of the bridge, your troops ferried very large numbers of men and material to the far side of the river. Thus when the enemy made an early counterattack, we were prepared.
- 4. Please extend to every officer and man of the 308th Engineer Battalion my sincere appreciation and thanks for their courageous and untiring efforts.


